Another wonderful day for the Rally participants. Morning at historic Coolamon and here this afternoon with a most interesting presentation on the development of farming, varied fruit production and irrigation at Leeton. All travelling well and tonight, at the Hydro Hotel, another very noisy dinner, so much so I can hardly write this report.

This morning, I had a visit from the "Rally Police" re the illegal parking of a Unimog: all will be duly revealed



First activity today was a guided visit to an organic rice farm near Leeton. We are now experts on the advantages of organic farming



Then I sprang a surprise on the Rally participants when we visited a goat feedlot at Murramai. No one expected this. We were given a guided tour of the feedlot operations, and whilst there watched goats being loaded on a stock transport for the abattoir. Then we went on to the Southern Cotton Gin at Whitton for a conducted tour of the plant. We have all just arrived at Mulwala for the next phase of the Rally. All OK and weather cooler today after two 30c+ days



## Rally Days 6 to 9

Lunch was at the Whitton Malt House which is an impressive new retail complex with accommodation facilities, lakes, and gardens. Lunch was enhanced with the option of sampling a range of local whiskies; just what you need prior to a 200Km drive! From Whitton we travelled to Mulwala via Coleambally, Jerilderie, and Berrigan. There was a strange sight as the cars arrived at Mulwala with the British Boys, Ian Baker and Geoff Graham, diving Anthony Lee's "hot" Mustang and the Lees driving the Rolls. At Mulwala we had a two-night stay at the very comfortable Club Mulwala Resort.

Next morning it was a short drive to the historic pastoral property of Savernake Station where we were given on a three-hour conducted tour of the homestead, woolshed, and outbuildings. The property has been owned by the Sloane family since the 1860s, and the existing homestead was built in the 1890s. In the evening, we had a dinner cruise around Lake Mulwala in the paddle steamer "Cunberoona."

On the Friday, the day's run was from Mulwala to Corryong. First stop was any of the Rutherglen wineries fancied, then lunch. In the afternoon some of the entrants visited the Army Museum at Bandiana, then it was on to Corryong via Tallangatta. Our final night dinner, and awards night, was at the Corryong Hotel.
